Santenoe was bitten yesterday according to the owner. I couldn't examine the dog as he keeps running away from me and he won't stand still when the owner tried showing me the wound.

Caesar was hit, according to the owner, by someone who was in their yard last night. His right hind leg is in the air and he is not putting a lot of weight on it.

7-day NTC issued to get both dog adequate veterinary treatment.

Roslyn's one dog who was limping last week is now doing fine. The dog is using the leg normally and running on it too. The other dog is yet to be seen by the vet. I provided them with the number of Swartland SPCA for assistance. The wound doesn't look like a bite wound anymore but rather like a injury caused by boiling water.

Comments: As advised, we have pulled half of our Inspectors from the road to attend to areas where people want to get rid of their pit bulls and other dogs. We had an incident yesterday where 3 pit bulls attacked a young girl, and she landed in the hospital. The community took matters into their own hands and brutally killed the dogs. One of the dogs was dragged down the road (still alive). The footage is sickening. This means that we will not be able to comply with Rule 5.4(a) and investigate all cruelty complaints within 24 hours. The non-urgent cases will unfortunately have to stand over. We will attend to them as soon as we can.

On top of this, there is a huge fire in Masiphumelele, and we are diverting the rest of our team to this.

General Report Comments: I arrived at the property which is at the back of given address and met with the owner. He was quite upset with the SPCA having a problem with his dog and there are so many other dogs that is in worse condition. I advised him that I am here to do a follow up and we are dealing with with him now because there were concerns. He took me to his puppy. I found the puppy on a stretching ropetied to a cabinete that serves as a shelter. His wife came out with a long chain in her hands and told me the puppy broke loose from the chain. I told Bernard that it is so unfair to have a little puppy tied up. He then loosened the puppy and allowed it to play. I then showed him the difference it made to the puppy, to be able to express its normal behaviour. He understood and told me that he will not tie up the puppy again and rather house train it.

I then went further back to where Roseline lived. I observed 2 dogs. Roseline told me that she cannot take her black and tan dog to a vet, he is very skiddish. She decided to surrender both dogs to SPCA and K admitted them as surrendered. Admission numbers 61784 and 61785.

I will do another recheck on the puppy in next week as the shelter needed improvement.
