I then got all his particulars and issued him with a warning to provide his dog with veterinary treatment within 48 hours and produce a vet's report. He lives at 20 2nd Avenue Fairways, Ottery. The reason for the 48 hours is that he needs to go back to work now and will only be able to look for a vet tomorrow when he gets paid. The dog has a chronic condition and needs to be seen by a vet. We can do a follow up within 48 hours for a vet report.
