General Report Comments: I met with the complainant at her home and she took me to where the horses are. On our way we spotted the horses that the concern was about and it was being ridden by children. I stopped the horses and asked the riders to get off for inspection. I checked the horses and found that both horses had very similar wounds in the same areas. One of the riders was a 17 year old boy named Dericko Farcah. And the other was a big of about 8-9 years old. I demanded that they do not ride the horses and to take the horses home. The complainant told me that the horses are normally free roaming like all the rest of the Chatsworth horses, but these boys keep on catching these two and rides them with sore backs. I issued Dericko with a warning stating that should he be seen riding these horses again, he will be liable for prosecution. Dericko lives at no. 1488 Victoria street. We then traced down where the owner of the horses lives which was 1422 Hopefield road. I met with a Yolanda Malegan who claims that those boys were told not to ride the horses and only care for them in terms of making sure they have water and food. She told me that the owner of the horses named Jerome Louw is not living in Chatsworth, but he is visiting. She could not give me a contact number or an address for Jerome. I issued a warning to provide the horses with medical/ veterinary treatment within 24 hours and provide proof of treatment. I will follow up tomorrow.

Yolanda also stated that the horses have since not been ridden and is left in the grass lands next to the reserve. I went around to where she explained but could not see the horses.
