General Report Comments: I arrived at the property and met the owner Andre with 3 workers. I went to have a look at the quarantine and found 3 dogs in quarentine. 1 puppy with what seems to be recovering skin condition. Andre claimed that it was an allergy. 1 older dog that was also recovering from skim problems and the other dog was completely healed as I could not see anything wrong with it. There were a couple of dogs that had someimor injuries thatvhas been treated. I told Andre that if his treatment is not working on his animals, then he must take them to a veterinarian. Andre stated that his treatment is working and that he has already rehomed 2 puppies that had skin problems. He also stated thay he took in 14 dogs over the December holidays that wants to surrender to SPCA because they do not get along with his dogs. I told him that I will only be able to fetch them in next week.

I will have to arrange with Swartland SPCA for a trailer to be able to fetch these dogs .

Aparently the dogs are vicious.

I will arrange this in next week. I will also do a recheck on the treatment. If the owner's own medical treatment does not help, I will issue a warning to seek veterinary treatment because his own treatment is not effective.
