General Report Comments: I arrived at the farm and met with the owner Mrs Yvette Coetzee who sent the complaint in . I went to the farm workers houses. I went from house to house. There are approximately 20 workers houses. 8 of these have dogs. At 3 of the houses 5 dogs were tied with chains because the yards are not fenced. Mrs Coetzee informed me that they are busy providing material to close all the farms workers yards. At house nr 11 the dogs were loose on the property but I saw a chain in the yard that was very short. I issued a warning for house nr 11 to provide the dog Mia with a running chain if they do chain her and also with a collar. Also for the brindle Boerboel x for adequate shelter. At house nr 19 I saw a brown mix breed dog named Noenoe who was sterilised that had a long chain but it was tangled without a collar. The area was also full of litter. I issued a warning for house nt 19 to clean the animals living environment, to provide the animals with a running chain and to provide the dog with a collar. At house nr 15 there were 3 dogs tied with long chains. The property is not enclosed. They all had shelter, food and water and all is sterilised. They did not have collars and I issued a warning for them to provide the dogs with collar. The rest of the animals at the farm houses were in acceptable condition and roaming freely. All dogs are sterilised except for 2. There is a rule on the farm that all the animals must be sterilised and the farm owner will sort out the sterilisation of the 2 remaining dogs. The dog in the picture that was sent by the complainant was surrendered to the SPCA. The person that is breeding with the pitbulls is no longer on this farm and Yvette will provide me with the details of where he is when she can. I will then check on that dog.
