- ② Stables 2, 3, 4, 5, 6, 7 and 8 are dirty, can smell dog urine and faeces lying all over, which indicate that the dog living area has not been cleaned.
- ③ Possible abandonment is suspected, because owner has not been to the property since 5/11/2024.
- ④ will follow up within 20 hours.
