General Report Comments: Upon arrival, I was met and granted access to the shop by Zita, the shop worker.

I observed the following animals:

8x Show Budgies
10 x Budgies
20 x Finches
3x Cockatiels
6x Lovebirds
20 x miniture lobsters
20 x Guppies
3x Goldfish

Birds:

The cages were clean, and are cleaned every morning. Fresh food and water is provided on a daily basis. The birds had sufficient perch space and the food is not placed under the perches . No over crowding was observed and the birds had sufficient space on the perches to stretch their feathers . The birds appeared to be in good condition with no veterinary or health concerns observed. I advised they slowly phase out the black sunflower seeds, and swap them with white sunflower seeds and also explained the reason why. And also educated Zita on the importance of species specific food as the lovebirds had budgies seeds to eat, this was changed immediately to a mixture of parrot food and the birds ate.

Fish:

These are the owner's personal fish and he is having renovations at his home. The fish have been brought to the shop till they are done. The tanks are also temporarily tanks. The one tank where the miniature lobsters are kept was low on water and rather dirty, according to Zita the owner said to her that she must please not clean this tank as he will come and clean on Thursday as they require special water etc.

I will come by next week again to check on this tank and that the birds are still receiving the correct food.
