General Report Comments: Upon arrival, I was met and granted access to the property by die owner, Marchel Tomas.

The dogs are kept in front of the house and on the right side.

Dog 1: Staffie x, Black/white, female, adult.

Kept in front of the house. Short static chain, approximately 2m long with a raw chain as a collar.

The dog has an adequate kennel, water and clean living environment.

Dog 2: Pitbull, male, adult, black/brindle/white, in tact.

Kept on the right side of the house. Short static chain approximately 2m long with a leather collar.

The dog has an adequate kennel, water and a clean living environment.

The owner does not have the funds to erect a running chain and asked if the get longer chains and place the dogs on 360 degree pens if it will be sufficient. I agreed and showed the owner where she can install the pens. The owner advised that she will try to have this implemented within the following 7 days.

A warning (W4608) was issued to:

1. Place the dogs on runners or 360 pens;
2. Cover the raw chain.

The dogs are in good condition with mo veterinary and/or health concerns observed.

The owner asked that if she manages to find some extra money if we can please assist with sterilisation, I agreed and gave her our number to call.
