General Report Comments: Upon arrival, I was met and granted access to the property by Uat.

The property has been cleaned thoroughly. Rubble has been removed, the feaces were picked up. No bad smell.

As I arrived at the property, Uat's 2x sons also arrived as they were dropped off by the school bus . I observed the situation and saw the gate opening up and taking some time to close.

The 2 boys went inside and another child then came out. The gate closed after about 15 seconds.

The 2x dogs were confined in the cages at the bottom of the property. They were both lying and seemed very chill.

Uat advised she placed them in the cages about 10min ago, just before the children will arrive. The dogs will be let out around 16h30 again. Meaning the dogs are only confined for 3 hrs max a day.

She claimed that they have been out the entire morning, till now.

She spoke more today, and mentioned that her neighbor at 34 Plein Str, complains when the dogs are outside as they jump the fence into her property. She mentioned this after I said she must put up a fence 7m away from the cages then it wont be an issue for the kids as the dogs wont reach them. The fence is rather high, but looking at the dog breeds and their body built I can belief that they can easily jump the fence.

Uat mentioned that she will gladly put up fence, however she will first have to raise the boundry wall. I asked her how long she tinks this will take and she advised that she will obviously first have to raise funds. Uat has complied with everything I asked and I trust she will make plan of this.

She said I can come and look in the mornings, any time before 14h00 and I will see the dogs free roaming inside the property. This I will do. When i am in the area, I will drive past in the morning and verify her claim.

I did not see a contravention in terms of the APA during my inspection .
