A tracker with 2x men approached me and the one identified himself as the farm manager. I asked the man if the owner is around, and he advised that the owner does not reside on the farm, and that henis in charge. I asked him regarding the foal and he advised that he spoke with the owner earlier today and that the owner advised he will advise him the way forward before the end of the week. He mentioned that the foal will likely be shot, which I agree with.

I confirmed the owners contact details and he confrimed that the number I have is correct. I tried to call the owner, however the phone went to VM. I left a VM for the owner to call me back urgently to discuss the plan of action.

I did not issue a warning as I first want to verify the point of action with the owner.

I will call the owner later today again, if he has not responded to my call yet.
