General Report Comments: Upon arrival, I was met and granted access to physically examine the dogs by Henrietta, the owners wife
I observed 2x dogs.

Dog 1: Ceasar, Xbreed, male, adult, BS 1/5 - underweight - chained

Dog 2: Min Pin x, male, 4 months old BS 3/5, slight skin condition - free roaming

Dog 1, Ceaser, is chained in front of the house on a running chain, however the dog cant use the running chain as the kennel is placed on top of the runner. The dog is underweight and does not look good.

I obtained the owners contact number feom his wife and called him to ask him what is his plan of action. He advised that he will get paid on Friday and take the dog to Malmesbury vet on friday. I advised that this is fine, and that I will follow up on monday. I also advised that he must provide me with proof that the dog was at the veterinary practice.

I finished the conversation by informing him if he does not take the dog for veterinary assesement that I will have nonother choice but to confiacate the dog and open a case against him. He understood and advised that he will make a plan, or call me if he wants to surrender the dog.

I issued a warning (W5217) stating:

1. Take dog for veterinary assesement within 72 hrs, proof must be presented on follow up inspection.
2. Place the dog on a running chain.
3. If you can't comply, you can surrender the dog

Follow up will be done on Monday.
