General Report Comments: ACCOMPANIED BY SWARLTAND MUNICIPALITY MALMESBURY LAW ENFORCEMENT OFFICER ERIN GOLIATH AND TEAM AS WELL AS FO PATRICK CHIWAWA

Upon arrival we were met at the property gate by two ladies who identified themselves as the owners, Ms. Nolikizana Faniso (Mother) & Ms. Andiswa Faniso (Daughter).

I introduced ourselves and explained that we are in possession of a Warrant granted in terms of Section 8(1) of the Animals Protection Act 71 of 1962. And informed her that we will be seizing the dogs today due to the condition the dogs are in. The owner kept saying that nothing is wrong with her dogs and that they have been like this for a long time and thay they are not sick.

The gate was closed with a latch and I asked Nolikizana Faniso if she is going to open the gate for us or must I open it myself, she advised that I must open the gate myself.

I opened the gate and entered the property.

I observed six (6) Xbreed type-dogs that all appear to have different stages of suspected sarcoptic mange. The dogs were free romaing inside the property, the property was extremely dirty with rubble, plastic and dog feaces scattered all over.

We proceded to capture the dogs and load into our vehicle .

I issued the owner with a Seizure Notice, which she signed and accepted.
