Marelize then took me to the back of the property where I observed a Maltese poodle inside her shelter. The Maltese poodle is 17 years old according to Marelize. The dog has food and water available. At that moment the complainant Mrs. Smith who also happens to be their neighbor came to the back and explained to me why she has called the Spca, Marelize and her mother in law swore at Mrs. Smith and exchanged a lot of swearing words. I told Mrs. Smith that I will come to her as soon as I'm done here. All the dogs on the property is in acceptable condition and is provided with adequate shelter, food and water. I then went to Mrs. Smith and told her that I could not find any welfare concerns and that the dogs are being cared for. I also told her that there is nothing the Spca can do about barking and howling and that she will have to call law enforcement in the future unless there is something seriously wrong with one of the dogs.
