General Report Comments: Upon arrival, I was met and granted access to the property by the owner's girlfriend, Meagan.

Meagan accompanied me to the back of the property where the dogs are kept. I saw the dogs kept in the same conditions as previously, except both had access to drinking water. The cages have not been enlarged yet, the owner still has 7days to comply as per the previous warning issued. Tequila still does not have additional shelter, and in my opinion the cage does not provide adequate protection against the weather elements.

According to Meagan, both dogs were dewormed, they bought deworming at Shoprite, BobMartin deworming tablets.

I asked Meagan what the owner's response was on the warning and she mentioned that he said the cages are big enough and that he is not going to make them bigger. I asked about the shelter, and she said he said nothing about that.

I issued a second warning stating:

1. Warning #5127 still stands and must be complied with, regarding the enlargement of the cages.
2. Tequila must have a kennel.
3. Faeces must be picked up daily.
