General Report Comments: Accompanied SBM LE Officers to conduct a welfare inspection as the owner applied to the Municipality to have more than 2 dog on his property.

Upon arrival, a young male approached us from the house and advised that the owner is not present, as he is at work. He indicated that he is a minor (15yrs old) and cant grant us access to the property.

We looked over the walls and could see the dog on the property.

There are 4x dogs on total. The 3x Pitbulls are free roaming and the boerboel is on a runner that is approximately 30m long and runs down the left hand side of the property till the far end of the property.

The dogs are in good condition with access to drinking water and adequate protection against the weather elements. In my opinion the property is large enough to accommodate 4x adult dogs.

Concern: The boerboel did not have a suitable collar fittend and has a chain as a collar.

Beside the chain collar, no other contraventions in terms of the APA was observed.

Warning issued:

1. Provide the dog called Bruno with a suitable material or leather collar.

A full property inspection is still due to be conducted by the Law Enforcement Officers , and arrangements were made to return to the property on Monday afternoon, as the owner is also home in the afternoons.
