General Report Comments: Upon arrival, I was met by the owner, Oceana. I shared the nature of the complaint with her and she advised that the 3 dogs I see are the only dogs they have. They don't have a greyhound or puppies. I also did not see a Greyhound or any sign of puppies.

The 3 dogs are free roaming inside the property, they are in good condition and their basic needs are met.

I called the complainant to verify if the address is correct, she advised that she "thinks so". I gave her the description of the property as well as of the dogs I saw and she then mentioned that she heard from a friend that someone came over the weekend to fetch the puppies. The complainant spoke very confusingly, and kept referring to a matter of last year, also about a greyhound and puppies. I am not sure if the complainant was actually referring to this matter of a year ago or if this is a recent matter, as she mentioned that she went and took the dogs away. I am not sure, however I know that there is no Greyhound with puppies on the property.

I asked the complainant to let me know, if she sees the Greyhound with puppies again, and also asked her to take a photo and sent it to me so I can have evident proof.

I will close this case, as the nature of complaint does not match my findings on the property.
