General Report Comments: Upon my arrival, the owner of the dog was not present. I was met at the premises by the following individuals, Gunther.

I entered the premises as I have permission from Mr Cilliers to do so. Gunther also entered the premises, not sure on whose authority he did so. He also took photos and videos.

I took a video from entry, as I walked through and captured all my findings.

There was food available for all the dogs. The bowls in the stabled area that had food in yesterday was finished, however in the one enclosed area where the one dog is kept there is still food in the bowl and the 2 dogs that are jumping in and out of the areas has access to this food.

There are large self feeders placed around with food inside. There were still of the other pellets with the cylinder shape and new pellets as well. Each of the self feeders were 1/3 full. I did observe some of the dogs eating during the time of my inspection.

There are multiple large water buckets placed all over, and they had water inside as well. All the areas where dogs are kept has water buckets with water available, even the puppies had water. The older puppies has a large self feeder with dog food inside, which they can eat from when they want.

The puppies are kept in socially compatible groups and I did not observed any bullying amongst them.

There are blankets inside the puppy enclosures. The blankets are dual folded preventing cold from the floor. The blankets were clean. The other dogs also have blankets placed around, and there are crates with cussions and blankets which they can lie in.

The one side of the large enclosure had new fresh feaces, I looked at the stools and they were normal, to a bit loose. No blood or worms were observed in the stools. The other side and inside some of the enclosures it was fairly clean and the dogs have access to these clean areas.

The dogs appeared to be bright alert and responsive and no veterinary or health concerns were observed during the time of my inspection.

I contacted the owner after my inspection as to enquire when he will be with the dogs again, he advised that he will be going there this afternoon to clean, and to top up the food and water bowls for the dogs. He will send me pictures as well when he is done.

He also advised that he acknowledged receipt of the final notice received from the property owner giving him till 3pm on Saturday to vacate the premises and advised that he will vacate and inform me as to where he is going.

No contraventions in terms of the APA was observed during the time of my inspection .

I will conduct another inspection tomorrow afternoon on my way home from work.
