Upon arrival, we were met and granted access by the current property owners, Amanda and Alec Dick, with contact numbers: 0715662094/0828950969

They are selling their property, and advised that Jan Cilliers came to meet with them last week Tuesday, and advised he is interested in buying but would like to rent the stabled area in the interim for his dogs. To which they agreed, but no contracts have been signed yet. He brought all the dogs on Saturday, and also slept on the property the evening. Cilliers was at the property over the weekend, Monday and left early Tuesday (today) morning.

Amanda accompanied us to the dogs and we observed all the dogs to have access to drinking water and a clean living area. The dogs also had food bowls with dog pellets inside. Amanda advised that Cilliers apparently made an arrangement with their groom to give water and clean for the dogs.

Amanda advised that they found out about Cilliers and his tricks and already advised him to take his dogs and leave their property, especially since no contract or agreement is in place and they are confident that he will vacate the premises before the end of the week.

Dogs observed today:
Total (including puppies): 23 (8x puppies / 15x adults)

Steel cage at the back of the main house:
1x adult, female, bl/wh
3x +/- 3-4week old puppies bl/wh
Cage size : 5m x 3m, solid roof, cement flooring, wire mesh fencing, shade net on one side, solid roof at the back. Blankets, self feeder with food, large water bowl.

Stables:
Size: 4m x 3.5m, wooden stables, cemented flooring. Straw placed inside as bedding, substrate.
Food bowls/self feeders (some), large water buckets.

Where the dogs have been marked with a "*" I recognized the dogs from the Hopefield premises.
