General Report Comments: As I was in the area today, I came to conduct my routine follow up.

Upon arrival, I entered the property as there is no gate and the main entrance to the house is at the back of the house. The main door was open and I called out to the owner. A man approached me from inside the house.

I introduced myself and asked if the owner is home, the man advised that she is currently at work. I advised that I am here to check on the kittens and he granted me access to the house to check on the kittens.

I observed:

1x Adult female cat, black with 6 black kittens still drinking from her.

2x Siamese(1x kitten, 1x young adult)

2x Tabby kittens (4months)

2x Black kittens (4months)

I am not sure where the other cats that I previously saw currently are.

The kittens of previous concern have healed well and there is currently no veterinary concerns observed.

The cats have water, food and a clean living area. The cats were laying on the bed and couches.

I messaged the owner to enquire if she would like to surrender some of the cats, at the time of my report she has not responded yet.

I will await her response, and if she does not want to surrender I will report the matter to Law Enforcement for the amount of cats she has on the property.

She did mention during my previous inspection that she wants to sterilize the adult females, but only from next year as she does not have the money now.
