Philip took me to the hedgehog where he/she was lying in a big plastic container with a heated blanket inside,there was also water and food available. The hedgehog has a eye infection. Philip told me that he has been cleaning the eye since yesterday when the owner came and brought the hedgehog to the petshop and asked them to look for a home for him. I told Philip that it is illegal to keep hedgehogs in the Western cape and that there no permits to keep them. The owner of the petshop decided to surrender the hedgehog because he does not want to get into trouble. I then phoned Donnie from Cape Nature to ask him what I must do with the hedgehog but he was in a meeting and could not answer my call. The fish tanks at the petshop is clean and the water is clear. Bird and hamster cages is also clean. Water and food was observed for all the animals at the petshop . Attached is a checklist that I have completed. Will recheck.
