General Report Comments: On my arrival, I met Mrs Millicent a domestic worker and Mr Boney a garden worker, I asked if the owner is present and they replied the owner was currently a work, Mrs Millicent then contacted the owner to notify her about my visit, then she said I must wait she will come, Mrs Surene Grootboom the owner the dogs she then arrived back to the property, I then introduced myself to her and explained my visit to her property, she then welcomed me into her property, I then observed 2dogs in the property (brown Mae boerbol of 5 months named Duster, and brown/white/black jack russel of 2 years named Rodi).

The boerbol was roaming freely inside the property.

The jack russel was in a camp on a static light chain of 4 meters long not to the collar around its neck.

Shelter was available, water was available and living environment was cleaned.

Both animals appeared physically looking good in condition with no veterinary problems or health concerns.

Both dogs was not underweight, and adequate food was available (dog pallets).

The boerbol had eye discharges but couldn't prove enough if it's got eye problems, and according to the she said did ask the vet about the discharges and the vet replied her by saying that she must for the boerbol to turn 1 year 6 months to see if the discharges are still showing up. The boerbol had a clinical card that it is upto date.

I then issued the owner with a notice to comply regarding the jack russel in the camp and about chaining, refer attached notice to comply.
