General Report Comments: Owner of the victimized dog:-
Itumelengs Maseko - 065 983 2472

Pitbull, 'Inu' male black and white, 10 month old was injured on the left eye. According to the owner Mr Sibanda who is also a Caretaker on the property attacked the dog when they were not on the property. He says they had locked the dog in the court yard.

According to the Caretaker Mr Sibanda the dog managed to get out of the court yard and they saw them when they were walking out with his wife and child. He said the Pitbull charged at him and he had a shambock because on the 01 July 2022 they attacked his wife. I saw the dog bite wounds on the caretakers wife.

Dog has been treated by Dr Kamo Motsepe, from PDSA 061 448 3559

The tenant who is also the owner of the victimized dog has two dogs :-

Pitbull xstaff type, Olivia female, 8months

Pitbull xstaffy type, male, tan and white.

The complainant dogs live inside the house and they don't go outside for 2 weeks now because over fears have attacked the caretakers wife.

The Caretaker's wife was attacked by the tenants dogs on the 01 July 2022

Landlord, Vincent Besteke, has no phone

Just when I was interviewing the suspect Vincent's dog had a go at each other. The one dog 'indica' was badly bitten her sibling 'setiba'. The owner surrendered her to the SPCA because he could not take her to a vet.

Indica was brought to the SPCA and she was humanely put to sleep after she was assessed by Patrick (AHT) and suspected to have suffered redium fracture muscle.
