General Report Comments: Upon arrival in the area I was able establish the address where the dog belong from asking members of the community. I met with the owner Phumalani Mtshikwana with telephone number 071 580 3388 / 011 443 5339. I proceeded to the address and found the dog at the property. The dog's living conditions were in satisfactory order. The owner then explained to me that the dog was sexually assaulted by Mr Mthokozisi Ronni. He said the suspect came and took the dog to his room at 135 - 15th Avenue, Alexandra. He further told me that soon after the suspect was discovered with the dog in his room by the community he was then attacked and beaten so badly he had to be hospitalized. He said his parents and family members came the following day after the incident to discuss an amicable solution. According to the owner they agreed that they don't want to see the suspect in the area as this would remind them what he has done to their dog which could make them fight him.

The owner surrendered the dog to the Sandton SPCA because he said he would never recover from the trauma he suffered if the dog was to still live with them. The completed the admission form and I took the dog straight to Wendywood vet. Upon examination by Dr Greenberg there were no human spems found inside the dog's vagina / vulva.

After the dog's examination I brought the dog to the Sandton SPCA. The dog appeared to be in good physical condition and it was very friendly.

I went to the suspect house and there was no one at the property. I left a warning requesting to be contacted.
