General Report Comments: I was informed by Mr Shiceka it's their religion/culture to slaughter animals and they do not slaughter animals everyday. They recently bought the property.
I educated & showed them regarding correct handling of animals. I informed them they should comply with the law and obtain a permit.
They wanted to offload the cattle and tie a cattle to a tree with a rope. I told them this will cause a cattle to stress and suffer since they don't have proper facilities, rather they slaughter inside a trailer to prevent unnecessary stress and prevent cruelty. The cattle was restrained in trailer and slaughtered, the head was held back to allow blood to flow. I checked the cattle for dead before dressing took place after 8 min
They did not want to stun nor shoot the cow.
The goats and sheep were isolated and they brought one at the time to be slaughtered out of other animals view. The cut was quick and knife was suitable size and informed to wait for 6 min minimum before starting to slaughter another animal. I checked for rhythm breathing, no eye reflex and no vocalisation for each animal.

Warning issued:- I intervene showed them proper way to handle goats and sheep must not drag. They carried them humanely and informed not to tie since the place is closed animals will not escape. Water was provided during my inspection and informed they must get permits to slaughter. Transport trailer must be kept free of projecting objects and must have registration number.
