The female dog on the other was not taken to the vet because a family member with a transport went away to Hammanskraal for the long weekend that is why they haven't been able to take the dog to the vet according to Mr Makeketa. The bitch was still in need of vet care because according to the owner, all they ever did was to use a Tree tea oil shampoo and using a Buchu oil spray. They stated that they had a similar issue with the male dog where these products were used and supplemented with a course of tablets given to the by some vet in Turffontein. I instructed them to take the dog to vet for a proper diagnosis and provided proof in another written warning within 24 hours. To follow-up by the 27th September 2024
