General Report Comments: At the property, I met the owners and his son Mr Solomon and Marothodi Makeketa and explained the reason for my visit. I mentioned the claims as reported to us to the owners about their dogs running in the street and biting someone, but they denied these allegations saying this never happened. I discovered that the owners are keeping the 2 adults, black & white, Pitbull male and female, dogs. The dogs are kept in a confined enclosure (but currently separated due to the female on heat) in the portion of the house that they are renting. The female was kept in the main enclosure where water and a kennel were provided while the male was separated in the passageway and they said they would be keeping them this way until the female reaches the end of her (oestrus cycle – being on heat) but with no shelter provided.

Their place appeared to be reasonably clean and maintained although their living situation was not ideal. However, the bitch had loss of hair on her rump (towards the tail) that indicated some skin irritation. Education was provided regarding sterilization for the female Pitbull(Owners offered sterilizationfused).I issued the owners with a written warning for not providing adequate shelter and to take the female to the vet for the skin irritation and send us proof of treatment from the vet after treatment within 48 hours. I still urged the owners to consider surrendering the dogs to the SPCA or finding an alternative suitable place for the dogs because subjecting dogs of this breed in such unfavourable living conditions may result in unpredictable behaviour and/or compromise their psychological well-being by the dogs. Still, they were not willing to do so.
