General Report Comments: I arrived at the retirement complex and was cleared at the security checkpoint, including the complex manager, who accompanied me to the unit to be investigated. We found a lady friend named Mrs Lynn Wells pet/house-sitting for the owner, Mrs Jill Wileman. The owner was away on holiday at the time of my visit, but the friend showed me the dogs and around the house. Mrs Wileman owns 2 old Jack Russell male dogs, "Skippy" and "Rex", 12 and 15 years of age, respectively. The dogs stay indoors, with potable water and sufficient dog food available for them. However, the dog named "Rex" appeared to be pacing around aimlessly and seemed to have lost some of his senses - hearing and impaired sight. His mental state appeared to be lacking logic because he would walk into tight or small spaces and never knew how to get out of such situations. According to the carer and the owner's friend, Mrs Wells "Rex" would also defecate randomly around the house, even though he has full access to the garden. The dog was never sent to the vet, most recently when I asked. I asked whether the dogs were on any medication, but I was told none at that moment, and no medical records were given to her by the owner. Given "Rex's" condition, I therefore issued a written warning to take him to a vet for a check-up within 24 hours and forward us a vet's report. To come in 2 days
