General Report Comments: Upon my arrival, I was met by Mr Trevor whose a worker at the property and introduced myself as an SSPCA Inspector Xolane . I explained the nature of the complaint which alleged that a dog from the property described as an Alsatian had attacked a member of the public's dog while they were walking their pet.

Mr. Trevor subsequently called the property owner Mrs. Dominique, to address the concerns. I inquired if she was aware of the alleged incident to which she responded that she had no knowledge of it. Mrs Dominique confirmed that Mr Trevor is responsible for walking the dogs daily .

During our conversation Mrs. Dominique asked Mr Trevor in my presence if the dogs had attacked another dog or if they had escaped the property at any point. Mr Trevor denied the allegations stating that the dogs are always walked on leashes and had not attacked any other dogs. Additionally, Mrs. Dominique confirmed that there had been no accidental escapes by the dogs.

During my inspection of the property I did not observe any Alsations on the premises nor did I identify any welfare concerns regarding the animals present.
There is no evidence to support the claim that an Alsatian from this property attacked another dog .
No further action is required at this time.
