Two adult dogs that were observed in a good condition at first came to the gate . I then went to the gate to observe the two dogs and the mother dog wasn't present.

I walked closer to the main gate and i observed the two dogs have external parasites. The dogs are in a good condition and clinically alert. The living environment is clean and hygienic.

I issued a warning

-To treat animals for ticks and fleas&/flies within 72 hours and continue treatment regularly.

-To contact inspector Lindokuhle on 83 270 1371 within 24 hours to discuss the concerns.

Point 6-The animals on your property were observed with external parasites. Seek veterinarian treatment within 72 hours.

When i was plugging the warning to the main gate. Themba arrived and I educated him regarding parasites. That they can cause tickby fever on the animals and he can buy Nextguard or Bravecto at any petshop. I further gave him an option to surrender the dogs if he can't look after them. He then refused and stated that he loves his dogs and he will comply to the warning as in the past two years SPCA removed his dogs with a warrant while he was in Eastern Cape .

I made it clear that if there is no compliance I'll remove the dogs with a warrant and press charges.
