General Report Comments: This case happened on 28 August 2018. The case was first declined at the Pinetown court. The docket was then transferred to Durban court and was declined once again and when I asked for a reason why it was declined they could never give me a reason. I then said I wanted the case reopened which they did in 2024 and then they lost the docket and it was an ongoing struggle. I would SMS the SPP every week to find out what was happening. Eventually we got it into court in July and on the 1 October 2025 the accused pleaded guilty and sentencing is on 10 October. The accused is repleading himself. After Lacey was signed over on the 28 August 2018 a warning was issued about not taking Lacey for veterinary treatment for both dogs being on short chains and then another warning was issued again for Bruno on 10 September and we then did regular checks on Bruno and he was not chained again.
