He contacted his father and i explained to his father that the dogs must be taken to the veterinarian. He told me that the owner is Syanda and he must make a decision.

Syanda surrendered all the dogs that are observed underweight.

I issued a notice to Comply

In future any animal that is sick or injured must be taken to the veterinarian for assessment and possible treatment without any delays

Failing to do so may lead into further actions taken against you for being on contravention of the animals protection act 71 of 1962 and allowing your animals to suffer unnecessarily.
