I made it clear to her that i came to do a welfare based on the nature of complaint we received. Saneles mother shared that the incident occurred when she opened the gate to drive outside. The property is not separated however they tried everything to stop the dogs from running outside.

We went outside with Sanele so i can do an inspection . I then interrogated him regarding the dog with a cropped ears. Sanele stated that he bought the dogs like that from colored guys while it was young (Video attached).

One dog was observed roaming freely in the front yard and it appears to be in a good condition. The dog is clinically alart and have access to shelter. On the ears there is no wound or blood as a sign that cropping was done recently. We then went to the backyard where 2 pitbulls were kept and the pitbulls were kept in this enclosure cos Sanele knew i was coming. For safety reasons that why he confined them at the back. Those two pitbulls were observed in a good condition and clinically alart. These two pitbulls have normal ears.

Sanele made an agreement with the owner of the dog that was attacked that he will settle the bill.

I issued a warning
To keep your animal/s inside your premises at all times.

There is no contravention of the animals protection act 71 of 1962 and there is no further action that can be taken. I strongly believe that the case can be closed.
