Both dogs were chained on the side of the house.
She told me that Mr Joseph Driman came to her property on the 27April 2026 opened the gate went to the dogs.
She her husband was not at home so she was very scared she opened the slightly and saw Mr Driman touching the Black (female) dogs privates part.
She saw him having oral sex with the female dog.
She said she took the photos.
She said she called the police but they didn't come.
The female dog was brought in for medical check up and the male dog was surrendered.
The case was opened, Cas 784/4/2026.
The suspect appeared in court on 14 April, bail was denied.
Cas postponed 21 April
Owner called me and said they don't want Black the female dog back.
