General Report Comments: In October 2024 the Fielding family adopted Buttercup from the Springs SPCA. The entire property is enclosed with precast walls of 1.8m height. The metal front gate has wide gaps that used to be reinforced with mesh but the new puppy (Buttercup) chewed through the mesh. All the dogs seen previously as well as the new dog were present. The front and back yards are separated with a wall and gate, but the back yard belongs to the garden flat in which the mother lives. The Peke and Collie are in the back yard as they are the mother's dogs. The two other dogs, cat and African Grey bird belong to the Fieldings. The other two dogs sleep inside the house at night but in the day they are outside alone in the front yard. In the front yard, there is an uncovered swimming pool. The dogs are in direct view of the street via the front gate, which makes the property risky for powerbreeds like a pitbull.

I discussed with the owner how to secure the property in order for Bruce not to be exposed to the street and be alone in the front yard during the day. Mr Fielding agreed to keep Bruce in the back yard with the mother's dog but also to reinforce the front gate to close it up.
