General Report Comments: Mrs Winn owns Winstead Stables which is a stable yard, riding and training school. On the same property as the stable yard is the house, where Mr's Winn's personal pet dogs live. However, during the day if Michelle is walking around the yard the dogs free roam. The Winn's are well known for being responsible owners who sterilise all their pets and provide the best veterinary and/or other medical treatment when needed. All five dogs are in good health and well socialised with all kinds of animals.

The house is closed off from the rest of the yard with metal fencing and wooden poles . The steel gate is reinforced with mesh. A large feeder is present inside and outside the house as well as around the yard. Various water sources are available throughout the garden and stable yard . The pool is fenced off with metal fencing to prevent the GSD from climbing into the pool whenever he feels like it.

A stable yard inspection was conducted after the pre-home inspection and no welfare concerns were found. Additionally, all the feral cats found throughout the stable yard have been sterilised with their ears clipped.
