General Report Comments: During an inspection conducted by the Springs SPCA on the 30/09/2025, the following conditions were found:

- i. Dogs Present: 4 x Pitbulls, 1 x Boerboel, 1 x Collie-type breed.
- ii. Boerboel – free roaming in front yard camp.
- iii. Female Pitbull – free roaming in front yard camp.
- iv. Male Pitbull – chained in front yard camp; visible injury to front leg with limping (explained to be related to the accident that had taken place in the yard). It was stated treatment is being provided.
- v. Male & Female Pitbull – chained in the back yard.
- vi. Collie-type breed – free roaming but with a chain around its neck.
- vii. Back yard – hazardous materials and debris requiring urgent cleaning.
- viii. Front yard (where injured male Pitbull is chained) – contains four cars, leaving very little safe space for free movement, hazardous material noted here.

Owner reported an incident that had taken place on the weekend with a car that went through their gate almost killing the children and dog in the front yard, due to no immediate welfare risks to the animals, I have decided to give them time to sort out the accident and will return on the 06/10/2025 for a follow up.
