General Report Comments: Upon arrival, a truck loaded with manure was observed leaving the property. A TLB was actively scraping manure into large piles on the property opposite the feedlot, which serves as the designated area for storing manure removed from the pens. Inside the pens, vehicles were also in operation, removing accumulated manure. The pens had dried significantly since the previous inspection.

Piles of gravel were present and were being used to reconstruct the flooring of the old pens after the removal of the muddy manure. The majority of the cattle had been relocated to the newly constructed pens situated on the opposite property. The remaining cattle were housed in the older pens that had dried out sufficiently, with no visible issues of their hooves sinking into mud.

All adult sheep were free-roaming in the grassy area of the opposite property, while only ewes with lambs remained in the sheep pens. Water and feed troughs in both the cattle and sheep pens were clean and well-maintained.

In the new cattle pens, the shaded roofing over the water troughs had not yet been installed; however, the feeding areas had been fully cemented, and the cement troughs had been completely installed. Each cattle pen was equipped with a bale of grass in addition to the concentrated feed.

All pigs had been transferred to the newly constructed pig pens. While only two pens were occupied during the previous inspection, this visit confirmed that four pens now contain pigs. Fly traps had been installed at both the new cattle and pig pens.
