You are hereby warned:

Following an on-site inspection conducted at 70 3rd Street, Rietkol, Delmas, at approximately 10:45 on the 10th of April 2026, several failures regarding the care and housing of your security dogs were identified.

Findings & Required Actions

- i. **Hydration and Sanitation:** At the time of inspection, multiple water bowls were empty, only being filled upon our arrival. Furthermore, several kennels contained dirty contaminated water.
 - a. All dogs must have 24-hour access to clean, potable water. This is to be rectified immediately and remain ongoing.
- ii. **Structural Hazards:** Pallets used within dog enclosures feature wide gaps. This creates an unacceptable risk of limb entrapment, fractures, or ligament injuries.
 - a. These pallets must be removed or modified to create a solid, safe surface within 72 hours.
- iii. **Medical concerns (2X Rottweilers):** The two Rottweilers (see attached photo) were found with visible diarrhoea within their enclosure.
 - a. These dogs must be examined by a licensed veterinarian within 24 hours. A formal Veterinary Report establishing the cause and the treatment plan must be submitted to this office within 48 hours. manager@spcasprings.co.za
