General Report Comments: I, Elani arrived at the property and met with the owner named Wilna. She showed me where they keep Jack most of the time when at work.

When they keep Jack in the front yard, they leave the door open for the dog to go in and out of the house for shelter. He has a cordoned off section in the washing room with a blanket and his water when this is the case.

If he is kept in the back yard, they have an enclosed veranda with couches, water and food. This will protect him from the elements.

He was kept here upon my inspection. They are thinking of keeping him more in the backyard as he does bark at any sounds or visuals that are strange. He is also extremely aggressive and unsterilized.

I noticed when he was barking that he has hairloss around his eyes and on his back which can be a possible skin condition.

I asked when they will be able to buy stuff for his skin and they said after payday but will try to get it beforehand.

I then issued a warning to:

1) Your dog Jack has a skin condition. Ensure to provide him with tick and flea treatment within 18 days. Keep proof of this. (E.g. Bravecto and Nexguard)

To follow up within 18 days after payday.
