General Report Comments: I, Elani arrived at the property and was joined by Fredericks from Law Enforcement.

Fredericks explained the reason we are there and John gave us access. We asked where the dogs were and he showed us one, Blackie, that was kept in a crate on the stoep. He couldnt really give a reason as to why she is in a crate which is unacceptable. He said the dogs are strays he found 4 months ago. We explained that according to law he is the owner of the animals.

He then took us to the back yard where two more dogs were free roaming. All of the dogs are emaciated. He claimed to have bought dewormer for them from the pet shop. I asked him what he is feeding the dogs and he said dog pellets and bones, potatoes and meat. I educated him not to feed potatoes, bones and pap and to buy proper dog food. He did not have dog food at the time of the visit. The dogs also did not have access to adequate shelter or potable water.

I then issued a warning to:

- 1) Provide Rex with adequate food (Bobtail puppy food) within 48 hours - No bones, potato peels and pap
- 2) Ensure your dogs always has access to potable water.
- 3) Provide Rex with dewormer within 48 hours.
- 4) Ensure to provide adequate shelter for Rex within 7 days (raised flooring, three sided walls, waterproof roof)

John signed Blackie and Jesse over for surrender and kept Rex. He signed the warning.

To follow up thursday to see whether be complied.
