The carer said we can walk around the property that was a smallholding. He owns 4 cats, 1 dog, geese and chicken. The entire yard is open around the house and all the animals can get to each other. My concern is the fact that the driveway is open to the main gate where the car pulls in and out. We need a cat and fowl friendly dog to stay here . Wife and carer are home at all times. All the animals are in good condition and have everything they need. The fowl have a pond to swim in.

Adriaan came to the SPCA and I asked him what the plan is with regards to pulling the car in and out. He says he is the only one that drives anywhere. He either takes the dog with if its a quick pick up and drop off for the carers or he leaves them at home when he goes shopping . He said he will inform the carers to keep the dog inside whilst he needs to go somewhere. The dogs are also allowed inside the house. I called him to inform him about food aggression and he said that he noticed and will keep an eye. He said the dog is sleeping on his bed as I was calling. I believe he will look well after the dogs as the home is lovely and clean. They have two kittens that has been vaccinated by WAHG this morning. Liz said she saw him there as well. He plans to sterilize them in April and took our forms as well. He is retired and I educated him about methods of training as he did work for law enforcement previously.

We had a good chat and he said we are mkre than welcome to come unanounced . Buddy went home today.

Gollow up in a month to see whether the dog has settled in.
