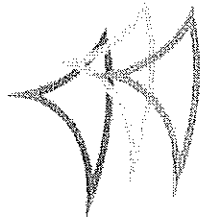

**APPLICATION FOR KEEPING MORE THAN TWO (2) DOGS ON THE PREMISES,
THREE (3), AT 9 E.LIMOSA STREET, DANA BAY, MOSSEL BAY**

Approval is hereby granted to keep more than two dogs on your premises and is limited to the case of 3 (three) dogs, until such dogs should die off or diminish and only two dogs per yard will be permissible according to the Municipal By-law regarding the regulation of the keeping of dogs, Pk 6678 dated 20 November 2009, subject to the following conditions, namely: -

1. That the dogs may not interfere with the ordinary comfort, convenience, peace or quiet of neighbours or any other people.
2. That the dogs will not be allowed on a public road or public place except on a leash and under control of a responsible person.
3. That the dogs do not trespass on private property.
4. That the premises where the dogs are kept, is properly and adequately fenced to keep such animals inside.
5. That you must reapply for the permit review no later than 2 January 2027.

The non-compliance with the above conditions may, upon further investigation of a complaint during which corroborating evidence is found and/or a conviction by a Court, this consent may be declared null and void.

- I understand that in case of illness (not injury) occurring within the first seven (7) days of adoption, I may bring the animal to the Society to be attended to by its veterinarian (at the discretion of the Society) at no charge to myself.
- I will ensure that the animal is sterilised as stipulated by the Society.
- I undertake to ensure that the animal has identification at all times, either in form of a microchip or a collar and tag - only elasticated or quick release collars may be used for cats.
- My property is adequately enclosed and at no time shall I knowingly allow my dog to roam the streets.
- I will notify the Society within forty-eight (48) hours should the animal die or go missing.
