General Report Comments: OBSERVED 2 ADULT MALE DOGS, 1 BLACK AND WHITE THE OTHER TAN IN COLOUR, BOTH INTACT. 1 ADULT FEMALE WITH 4 PUPPIES (2 MALE AND 2 FEMALE) ABOUT 4 WEEK OLD. I OBSERVED THAT THE TAN MALE DOG WAS SITTING ALONE, FAR FROM THE OTHER DOGS, A FEW SCARS WERE OBSERVED ON THE FACE AND FRONT LEGS. THE OWNER ADMITTED THAT THE OTHER BLACK AND WHITE MALE WAS ALWAYS CHALLENGING AND ATTACKING THIS MALE TO DISPLAY DOMINANCE. OWNER AGREED TO SURRENDER THE MALE DOG AND AGREED TO HAVE THE REMAINING ADULT DOGS STERILISED. HE CLAIMED TO HAVE FOUND GOOD HOMES FOR THE PUPPIES WHEN ASKED TO SURRENDER THEM ALSO. A WARNING WAS ISSUED TO THE OWNER TO PROVIDE ADEQUATE SHELTER. HE COMMITTED TO PROVIDE THE DOGS ACCESS ON THE ONE SIDE OF THE DOUBLE GARAGE AS SHELTER WHICH HE PREPARED WITH BEDDING AT THE TIME OF MY VISIT. HE ALSO COMMITTED TO ACQUIRE PROPER DOG HOUSES WITHIN 7 DAYS AS PER WARNING. (10/12/2025)
