condition. Drinking water was dirty including the water bowls
& food bowls. Old droppings on the floor indicating a lack of regular cleaning.
The dogs were kept in cages depriving them adequate roaming space.
The owner was further advised to sterilise all his animals. The
yard is well fenced & the dogs were let loose immediately. A warning
was issued for all the concerns & the owner was further
advised to provide forms of enrichment for his dogs.

→ Both water & feeding bowls should at times be kept clean → Rectify immediately.

→ We recommend that you sterilize your animals.

→ To provide proof of the above rectified to 073 260 5917 or to Manager @ thehidrandspca.co.za within the above timeframe.
