

MUTUAL AGREEMENT

between the

Najima Van Der Rheede

("The owner")

And

The Cape of Good Hope SPCA
("The SPCA")

I, **Najima Van Der Rheede** with ID number 8705080167089, hereby confirm that I am the lawful owner of the Jack Russel x called Sky (Admission number 90211), seized by the SPCA on 29 January 2023 in terms of the Animals Protection Act 71 of 1962, Regulation 468.

The SPCA has agreed to return Sky to my care on the following conditions set out below:

1. I undertake and commit to the following:

- a. I am over the age of eighteen (18) years of age and of sound mind. I am the parent/guardian of Aailah Van Der Rheede.
- b. I will ensure that Sky is not subjected to any neglect or terrified by any person. I understand that this is a contravention in terms of Section 2(1)(a) of the Animals Protection Act 71 of 1962.
- c. I commit to complying with all the provisions of the Animals Protection Act 71 of 1962 and take full responsibility for the animals in my care. I further commit that my daughter Aailah Van Der Rheede will not be permitted to leave the property with Sky unless accompanied by an adult person of sound mind.
- d. I herewith consent to the SPCA sterilising Sky. I understand that sterilisation is a surgery to make my animal unable to produce offspring. I further confirm that I will not hold the SPCA or its officials liable for sterilising/neutering my animal and or any complications resulting thereof, and I authorize the use of anaesthetics and other medications, as deemed necessary by the attending veterinarian.
- e. I herewith consent to the SPCA microchipping Sky.
- f. An Inspector of the SPCA will be permitted to inspect Sky at my premises at any reasonable time to ensure ^{her} ~~his~~ welfare and well-being and to ensure compliance in terms of the Animals Protection Act 71 of 1962.

I confirm that I understand that this mutual agreement does not preclude me from any criminal prosecution. This is a voluntary mutual agreement reached between myself and the SPCA to mediate the matter without involving the courts. I understand that the SPCA reserves the right to proceed with criminal charges against me in terms of the Animals Protection Act 71 of 1962 should I fail to comply with this mutual agreement.
