General Report Comments: Upon arrival at the property I met with owner who was very cautious and very unhappy with the situation as he thought I'm there to take his dogs. I informed him that we were notified of the dogs fighting and that no one is home unfortunately but atleast I saw him and asked to see the dogs.

I observed the xbreed dig inside the house which I saw the owner cleaning the dogs wounds which he appeared to sustained minor wounds from the neck and head area. The wounds are that deep or serious, the other dog was at the back as well and his face Aldo had minor wounds (scaring in the face which was not deep as well and owner cleaned his face as well. There was shelter but area was dirty and obstructions seen upon inspection that could potentially cause unnecessary injuries to the dogs. The dogs appeared to be in fair condition however

The owner showed me the silbercor for the cuts which he is treating himself and I gave a warning stating that the owner should within 7 days:

1. Separate dogs at all times keep one inside the house and the other outside with access to clean area and drinkable water
2. Clean the cuts on dogs face and carry on treating with treatment ointment silbecor
3. Clean up the animals living conditions as well
