CHECKLISTS

General Report Comments: Upon arrival i met owner's son; introduced myself then asked him what kind of vihcles they have on the property. He then told me that they own the silver BMW parked outside in front of the property and a white Ford Ranger. I then asked him what the registration of the white Ford Ranger is. He than told me that he is going to call his mother as he does not know the vihcle's registration.

His mother came out and asked me what I was looking for. I then told her that we received a complaint about a vehicle and by the sound of it they are the owners of the vehicle in question and for that reason I would like to see the vehicle registration. She than wanted to know why I wanted to see their vehicle registration. I than shared with her about the cow that was tied up in a inhumane way at the back of the vehicle which I spoke about.

She than sarcastically said that I am wasting my time and her time as cow in question had already been slaughtered and if anything we should have been present when it was slaughtered. I then said that it is unfortunate that we could not be present for the slaughtering of the cow, but that today i am here to issue a Notice for the way the cow was transported. She then got upset and told me that I am here to do a white man's job and that I should look around in other areas as there is alot of cruelty happening to animals and not at them for doing something that their culture requires.

She then added that I must issue the my silly little Notice as it is my job, but all I must know is that they are going to continue to do what they want and that there is nothing we can do about it. She then also said they also got the registration for the vichle of the white man who was pestering them and that I must tell him to mind his business as I will be giving him feedback.

I then issued a NTC for the owner of the vichle which is her husband: To use suitable transport when transporting a animal, railings must be high enough to ensure/ prevent the animal from jumping over as that may cause unnecessary injuries to an animal and to ensure u do not tie the cow to it's horns in the inhuman why which it was tied to.

Failure to comply may lead SPCA to take further steps in terms of law , Animals Protection Act no.71 1972.

As the owner's partner went into the house while I was writing the Notice she told me the Notice should have been prepared before I came to the property. That I must call her when I am done. I then called her when I was done and asked her to come and sign. She then told me that I must read the Notice to her before she is going to sign. I then explained to her that is usually what I do I just needed her to come out so I could start.

As I read the Notice to the owner's partner she stopped me and asked how high (referred to the railing) is high enough and I told her that because she saw how big the cow is when they get to the place where they make these high railings she will see which one would have been suitable for the cow they transported and they must take that one. She then asked me for measurements and I told her I am not sure of the measurements, but that she must use my advice for future reference. She then told me that I must know the measurements of things. She then pointed me to her vibacrete fence and asked me how high that is. I then told her I don't know, but that if that was for the cow it would have been high enough. She then asked me again what the measurements of her wall. I then said it looked like 2meters in height and she said sarcastically that it is not 2meters, but 1.8meters.

I then read the notice further and she stopped me again asking Should they not comply further action to be taken? I then said yes as they need to ensure the next animal must not be transported in the same way. I then told her to allow me to finish reading and if she has any questions she may then ask. She then told me that I have an attitude and she will not sign. I then said if she does not sign I will stick the notice to the gate and she said I may stick it to the gate as she is not signing anything and I must leave her property.

I then left the property to go collect a water proof flipfile bag to put the notice in and to stick it to the gate with the cello tape. As I went to the bakkie collecting the above mentioned she said she is going to get her phone and record me. Getting ready to put the notice on the gate she started recording me and made sarcastic comments about the SPCA come to her property to do white people's jobs and that we are forgetting her tax pays our monthly earnings. I stuck the notice to the gate and she started saying I look dirty. I then said that it is because I have been working the whole day. She told me that I drive a shifty vichle and she will borrow me her BMW. After sticking the notice to the gate and waiting to take a Picture she came around and tried to rip the notice from the gate. I stopped her and said I want to take a picture and that she must allow me to do my job. She said I can take a picture, but must not use so much tape on her property. That I must take a picture with her in it as she was standing behind her fence where I stuck the notice. I then took the picture

and left the property.
