he mentioned that, he is looking after the work place, his PSIRA was not with him, he promised me that, he will bring it when we come back for the follow up.

I have observed the dog that appeared to be in a fair condition, the dog was secured to a running chain that appeared to be long enough.

The living environment was not clean there was rubble and there were old faeces laying next to the dog, there was a wooden shelter that appeared to be adequate, there was no water provided to the dog, I have instructed the security to give water, he complied, the security called the owner of the dog to get me him that, the SPCA was onto the property, the owner confirmed that he is the owner of the dog,

he also confirmed that he doesn't leave onto the workshop, I have told the owner that, he will need the PAPA license as the dog has been used for safe guarding or he will have to remove the dog, and he will have to provide us with the new address, where the dog will be taken to.

The warning was issued as follows.

1. The dog must always have access to drinkable water at all times.
2. To pick all faeces and remove all the rubble that may cause unnecessary injuries to the dog, within 24 hours.
3. To provide the SPCA with the Performing Animals Protection Act license within 72 hours.

The warning was signed and accepted by the security.
