According to the mother who sound to be the complainant her son said be will slaughter the sheep on Christmas day.

She also showed me another enclosure, where she told me that, there are chickens kept in there, we have moved to the back window, where I have observed the tan and white pitbull chained up with a short static chain, I didn't see the water. The living environment was not clean, there were car parts everywhere, there is no space for those animals.

As the owner is always not at home, I think we need to obtain the warrant and remove all the animals
