Comments by Inspector:

At our arrival at Ummati Farm, the premises were still locked. We met with caregivers and they granted us access to do our inspection. We observed one of the pens and a sheep lying down ~~unable to stand up was seen.~~ The sheep appeared lame and unable to get up and we called the owner to inform him which he informed us to slaughter the animal. The rest of the sheep appeared to be in fair health condition. Shelter was provided as well but he was just keeping the animals for the people to come and fetch otherwise he is slaughtering.

There was water provided, but the owner mentioned that they were not going to feed them today ~~as they are waiting for their owners to collect them.~~ I informed him that irrespective of that he needs to feed the animals. We also observed that all sheep that were in different pens were in fair condition.
